This is in response to your request under the Privacy Act received on April 23, 2012, in which you seek; "Milton's detachment's file pertaining to the alleged fraud with respect to the artwork of Norval Morrisseau".

Based on the information provided, a search for records was conducted in Milton, Ont. Please note that all the information reviewed qualifies for exemption pursuant to Subparagraph 22(1)(a) of the Act. We have however exercised the discretionary power provided by the Act and severed some information. Find enclosed a copy of all the information to which you are entitled.

**INVESTIGATION SUMMARY** 

## **Allegations**

Allegations were made to the RCMP that the marketplace is being proliferated with counterfeit Morrisseau paintings and that many of these paintings are being created by some of Morrisseau's biological children and others who are re-producing his works of art and/or forging his name. It was alleged that several art galleries and individuals in the Greater Toronto Area,

### **Investigational Goal**

The goal of the investigation was to obtain evidence and establish if sufficient grounds existed to support copyright infringement contrary to the Copyright Act and criminal offences within the mandate of the Greater Toronto Area Federal Enforcement program.

#### Background

Norval Morrisseau, deceased, (1932-03-14 to 2007-12-04) was a renowned Aboriginal Canadian artist who was honoured as a Member of the Order of Canada in 1978. His works of art are part of many collections found in the National Gallery of Canada, Indian and Northern Affairs, and the Royal Ontario Museum in Toronto.

During his lifetime it is estimated that Morrisseau painted in excess of 10,000 works of art, and to date, approximately 1,000 paintings have been catalogued by the Norval Morrisseau Heritage Society. There were many years where Morrisseau lived a transient lifestyle. He sold or traded his art work for very little money and in exchange for art supplies, alcohol and food. As a result, no records exist to account for a significant number of his paintings.

Investigators have interviewed numerous individuals including art gallery owners, members of the Norval Morrisseau Heritage Society, friends, family and art experts.

Investigators did not identify nor obtain the requisite evidence necessary to support the allegations of criminal activity involving individuals and Art Galleries located in the Greater Toronto Area, and have concluded that persons connected with

have not

committed offences under Criminal Law.

RCMP investigators have exhausted all investigative leads in the Greater Toronto Area, and evidence to support charges under the Copyright Act and the Criminal Code of Canada was not identified during the course of this lengthy investigation.

It is recommended this investigation be forwarded to Thunder Bay Police Service for consideration of any followup action deemed appropriate.
