### SUPPLEMENTARY AFFIDAVIT OF GRACE SHAFRAN (affirmed December 11, 2015)

1. GRACE SHAFRAN, of the City of Toronto, in the Province of Ontario AFFIRM:

- I am counsel to CTV, a Division of Bell Media Inc. ("CTV") and have been since June, 2000. As such I have knowledge of the facts hereinafter deposed. Where that knowledge is based on information obtained from others, I have so stated, and verily believe that information to be true.
- 2. On October 8, 2015, I affirmed an affidavit in support of the motion by Bell Media Inc. ("Bell Media") to dismiss this claim pursuant to Rule 12.02 of the Rules of the Small Claims Court. I affirm this supplementary affidavit to respond to the following issues raised in the Plaintiffs' responding materials on the motion scheduled for December 15, 2015:
  - (a) the timing of CTV's second broadcast with Donna Child, the Gallery Director of Artworld Fine Art, and Dr. Atul Singla, a handwriting expert, regarding the litigation and authenticity of the Norval Morrisseau painting "Wheel of Life"; and

(b) the request made to YouTube to remove CTV's broadcast of February 7, 2014 from its site.

### Early Request for Interview with Donna Child and Atul Singla

- 3. As set out in my affidavit of October 8, 2105, CTV broadcast an episode of the program Canada AM on the subject of Canadian painter Norval Morrisseau ("Morrisseau") on February 7, 2014 (the "first Broadcast"). The broadcast followed an article on the Canadian Broadcasting Corporation website that two Canadian musicians, Kevin Hearn and John McDermott, had issued claims alleging that they had purchased fake Morrisseau paintings.
- During the first Broadcast, Ritchie Sinclair, a witness in Hatfield v. Child et al., spoke about his testimony in that litigation. The case specifically involved the authenticity of the Morrisseau painting "Wheel of Life".
- 5. Shortly after the first Broadcast, on February 24, 2014, CTV invited Donna Child to appear on Canada AM to discuss the authenticity of Wheel of Life. Ms. Child is the gallery director of Artworld Fine Art and named party in Hatfield v. Child et al. CTV also invited the handwriting expert who testified in the Hatfield v. 10. On April 10, 2014, I wrote to John Goldi and set out the efforts by CTV to have Ms. Child on Canada AM to discuss Hatfield v. Child et al. and the authenticity of Wheel of Life. Attached hereto at Exhibit "A" is a copy of my email to Mr. Goldi of April 10, 2014.

### Request for Removal from YouTube

- On February 24, 2014, I contacted Toby Lang, senior counsel at Bell Media about the posting of the First broadcast on YouTube and to request its removal.
- On February 25, 2014, Mr. Lang confirmed to me that YouTube removed the video clip of the First broadcast from its site.
- 13. Despite Bell Media's demand for removal, the video was re-posted on YouTube. Mr. Lang informed me that the reason it was re-posted was the issuance of a counter-notification by Ritchie Sinclair. Neither YouTube nor Mr. Sinclair would remove the video.
- 14. I affirm this supplementary affidavit in support of Bell Media Inc.'s motion to strike the Plaintiffs' Amended Amended Claim and for no other or improper purpose.

Please be advised that I am counsel to CTV News. Your letter of April 1 2014 has been forwarded to me.

I wanted to let you know that CTV has been taking a second look at this story for some time. Canada AM has been in contact with Donna Child, Gallery Director of Artworld Fine Art, since February 24<sup>th</sup> to arrange an interview with her to come on Canada AM to discuss the Morrisseau allegations as well as the lengthy court case her gallery was involved in, regarding the authenticity of the Morrisseau "Wheel of Life' work.

You may also be interested to know that prior to the airing of the interview with Ritchie Sinclair, CTV had tried to arrange an interview with Joseph McLeod of Maslak McLeod Gallery, in response to the lawsuits filed by Kevin Hearn and John McDermott against his gallery. Mr. McLeod, referred us to his lawyer Brian Shiller, who had also acted on Ms. Child's behalf as I am sure you know.

Mr. Shiller was also not available to appear on Canada AM.

While CTV had expected the interview with Ms. Child to air by now, they are still waiting for her to be available to conduct the interview which is expected in the next week or so, hopefully. CTV is also expecting that Dr. Singla, the handwriting expert will also be interviewed together with Ms. Child. I can forward the link to the report once it has aired.
